BIOMET TERMS AND CONDITIONS OF USE

Welcome

WELCOME TO THE BIOMET SURGEON NETWORK (THE SITE), WHICH IS OWNED AND OPERATED BY BIOMET INC. AND ITS AFFILIATES OR SUBSIDIARIES (COLLECTIVELY, "BIOMET"). PLEASE READ THESE TERMS AND CONDITIONS OF USE (THESE TERMS OF USE) CAREFULLY. BY ACCESSING OR USING THE SITE, BY USING ANY INTERACTIVE AREAS OF THE SITE (DEFINED BELOW), OR BY UPLOADING, BROWSING, VIEWING OR DOWNLOADING ANY MATERIAL FROM THE SITE, YOU AS USER AGREE TO BE BOUND BY THESE TERMS OF USE AND ALL POLICIES AND GUIDELINES INCORPORATED BY REFERENCE HEREIN.
